The HCA helps to ensure our continued quality of life in the Highlands.

**Highlands Recreation District runs the Rec Center.**

Do you know the difference between the Highlands Community Association (HCA) and the Highlands Recreation District (HRD)? The HRD manages the Rec Center and is partially financed by property taxes collected by San Mateo County. All Highlands residents are automatically members of the HRD and pay resident-level fees for activities there. Only those households who pay their \$30 dues are members of the HCA.
